

CONSTITUTION OF THE STUDENT 2 STUDENT CLUB OF
JAMES CLEMENS HIGH SCHOOL

Preamble:

We, the students of James Clemens High School S2S team, are a unified, determined, and energetic team. We aim to help all students entering our school feel welcomed and loved and make their transition to James Clemens one of comfort and ease.

Article 1. Student 2 Student of James Clemens High School

Section A.

It is resolved that the name of this organization shall be the Student 2 Student Club of James Clemens High school.

Article 2. Purpose

Section A.

1. To create a positive atmosphere for incoming new students at James Clemens High School.
2. To achieve easy transitions for incoming and outgoing students.

Section B.

1. To connect military-connected and civilian students together.
2. Host social events that allow new students to meet people within their school.
3. Be active in the community, and represent James Clemens High School in a positive manner.

Article 3. Membership

Section A. Membership in Student 2 Student is established by an application process, where a student must meet the necessary membership requirements stated.

Section B. Membership in Student 2 Student is maintained by staying active within the club and maintaining the membership requirements stated.

Section C. Membership Requirements (not following these requirements can lead to removal from club)

1. All members must maintain a 3.0 Weighted GPA and have no failing grades.
2. Members must have no major disciplinary problems through the school year. (if you believe unreasonable, an appointment can be made with Mrs. McLaughlin)

3. Members must maintain regular attendance club meetings and functions. This should be around at least over 75% of the meetings and at least 2-3 functions or projects. Excuses are accepted.
4. Members must be committed to Student 2 Student, as it is a huge responsibility to be a member of this club.
5. Members must represent James Clemens High School, and the Student 2 Student Club well.
6. Every member must be involved in at least 1 service project throughout the year.

Article 4. Duties

- Section A.
1. To assist new students in finding their way around James Clemens High School until they no longer need help finding their classes.
 2. To assist new students in the areas of Academics and Relationships, as this school may be entirely different from their previous school.
 3. To organize meetings, events, activities, and training sessions.
 4. To continually ensure that the program is sustained by training members to lead the program, as others graduate or relocate.
 5. To be active participants in fundraisers that gain money to support the efforts of S2S.

Article 5. Club Officers

- Section A.
- Elections
1. The positions of club officers will be decided by a simple vote available to all members of the club, with the majority of votes winning each office.
 2. In the event of a tie, the advisors will decide.
 3. If a spot remains vacant and no members run for the office position, an advisor will recommend a student to do the job until one is found that agrees.
 4. Elections shall occur at the end of each school year, specifically by the last meeting in May.
 5. Previous members, graduating that year, will not have a vote that counts in the election.

Section C. Officers and their Duties

1. President
 - a. Run meetings
 - b. Make and stick to agenda for meetings
 - c. Serve as official spokesperson for S2S
2. Vice President
 - a. Assist the President when called upon
 - b. Take the position of the President when he is not present

- c. Serve as another spokesperson for S2S
- 3. Secretary
 - a. Work closely with other officers
 - b. Maintain S2S records and attendance records for club meetings/events
- 4. Historian
 - a. Work closely with other officers and document events of the year
- 5. Service Project Chair
 - a. Helps finds community service projects in the community
 - b. Gets S2S actively involved in the community service projects
- 6. Social Events Chair
 - a. Handles hosting social events when needed
 - b. Runs those social events
- 7. Marketing Chair
 - a. Works with promotion and media

Section D. Recall

- 1. If the general club membership feels that one of their club officers is not fulfilling his or her duties they must contact an advisor, state their case, and let the advisor handle the issue.
 - a. Advisors hold the power to remove you from office if you are not doing your job.
 - b. If a member is removed from office, a meeting will be held for an election for this open position and the election process will take place.

Article 6. Amendments

Section A. This constitution shall be amended by a 2/3 majority vote of the membership provided.
